### Proof of Income

Proof of income (tax statement(s) or recent check stub) will be required for use of the sliding fee scale discount rate. Discount will begin when proof of income is supplied.

### Overtime/Late Charges

Overtime fees are charged when a child is dropped off before 6:45am or picked up after 6:00pm at the rate of \$2.00 per minute.

### One-Hour Minimum Charges

Program usage for *less than* one hour is calculated at the rate of one hour *each* time a child is signed in/out and applies to 1) before school care, and 2) after school care *which includes use of busing to school or a CAP site.*
